**A RESOLUTION OF THE CULLMAN CITY COUNCIL
CONCERNING THE REQUEST FOR AN ATTORNEY GENERAL'S OPINION FOR THE
CITY OF CULLMAN SELLING DRAFT BEER**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF CULLMAN, ALABAMA, AS
FOLLOWS:**

SECTION 1. The City Council request clarification on the legal selling of draft beer in the City of Cullman. The Code of Alabama 1975 Volume 16-A Title 28 does not clarify the legal sales in Cullman County.

The City of Cullman Officials request the Mayor Max A. Townson, to contact the Attorney Generals Office to get an opinion as soon as possible to complete the new Alcohol Ordinance.

SECTION 2. This Resolution shall be effective immediately.
